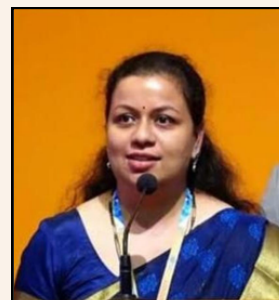
Dr. Shivani Mohan

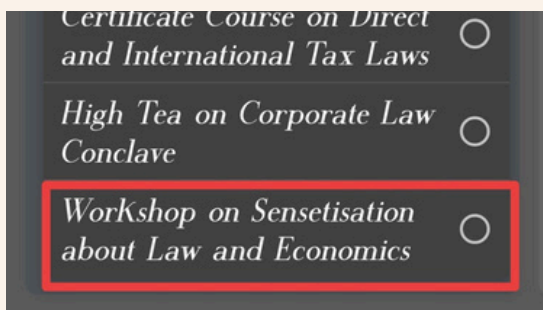

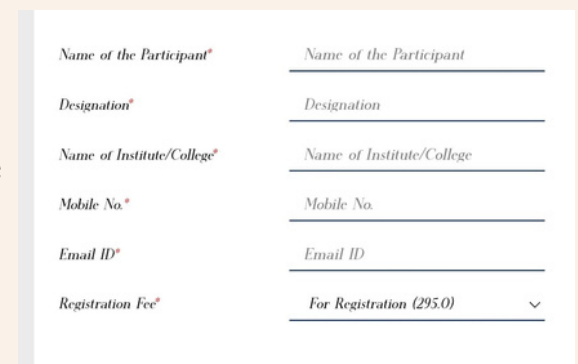
